All students who live within the home zone described below shall be eligible to enrol at the school.

Year 7&8 Home Zone


From the intersection of Seadown Road and Phar Lap Road,

- South East along Phar Lap Road to the intersection with Kereta Road
- East (across country) to the coastline
- North East along the coastline to the Rangitata River
- North West along the south bank of the Rangitata River to the eastern end of Dip Road
- South West along Dip Road to Rangitata Island Road
- North West along Rangitata Island Road to Burnham Road
- South West along Burnham Road to the Orari River
- West across the Orari River to Ohapi Settlement Road
- West along Ohapi Settlement Road to Muff Road
- North West along Muff Road to Barker Road
- West along Barker Road to the Winchester - Orari Highway (SH1)
- North along the Winchester - Orari Highway (SH1) to Beeby Road
- West along Beeby Road to Winchester – Geraldine Road
- South along Winchester – Geraldine Road to Winchester – Hanging Rock Road
- West along Winchester – Hanging Rock Road to Goodwin Road
- West along Goodwin Road to Seven Sisters Road

Year 9-15 Home Zone

From the intersection of Seadown Road and Phar Lap Road,

- South East along Phar Lap Road to the intersection with Kereta Road
- East (across country) to the coastline
- North East along the coastline to the Rangitata River
- North West along the south bank of the Rangitata River to the eastern end of Dip Road
- South west along Dip Road to Rangitata Island Road
- North West along Rangitata Island Road to Burnham Road
- South West along Burnham Road to the Orari River

- West across the Orari River to Ohapi Settlement Road
- West along Ohapi Settlement Road to Muff Road
- North West along Muff Road to Barker Road
- West along Barker Road to the Winchester - Orari Highway (SH1)
- North along the Winchester - Orari Highway (SH1) to Beeby Road
- West along Beeby Road to Winchester – Geraldine Road
- South along Winchester – Geraldine Road to Winchester – Hanging Rock Road

- South along the eastern bank of the Opuha River and Opihi River to a point in line with the northern end of Gould Road
- South East along Gould Road to Gays Pass Road
- South along Gays Pass Road to Totara Valley Road
- West along Totara Valley Road to Raincliff Road
- North West along Raincliff Road to Monument Road
 - Including address 154 Raincliff Road
- North West along Monument Road to Sterndale Valley Road
- South West along Sterndale Valley Road to Henriksen Road
 - Including address 17 Timewell Road
- West along Henriksen Road to the end of the road
- West across country to Brothers Road
- South East along Brothers Road to Cleland Road
- South East along Cleland Road to Pleasant Point-Cave Highway (SH8)
- South West along the southern side only of Pleasant Point-Cave Highway (SH8) to Davison Road
- South East along Davison Road to Taiko Road
 - Including all addresses on Summit Road
- South along Taiko Road to Limestone Valley Road
- South along Limestone Valley Road to Taiko Road
- North along Taiko Road to Taiko Hall Road
- East along Taiko Hall Road to Sutherlands Road
- East along Sutherlands Road to Rolling Ridges Road
- North East along Rolling Ridges Road to Timaru-Pleasant Point Highway (SH8)
 - Including all addresses on Levels Valley road south of Rolling Ridges Road
- South East along Timaru-Pleasant Point Highway (SH8) to Divans Road

- Including all addresses on Breen Road
- South East along Divans Road to the Timaru – Temuka Highway (SH1)
- North East along the Timaru – Temuka Highway (SH1) to the intersection with Hedley Road
- South East across country to the intersection of Seadown Road and Phar Lap Road.

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Applications for enrolments will be processed in the [following order of priority](#):

1. **First priority** is not applicable at this school because the school does not run a special programme approved by the Secretary for Education.
2. **Second priority** must be given to any applicant who is the sibling of a current student of the school.
3. **Third priority** must be given to any student who is the sibling of a former student of the school.
4. **Fourth priority** must be given to any applicant who is the child of a former student of the school.
5. **Fifth priority** must be given to any applicant who is a child of an employee of the school's board or a child of a member of the school's board.
6. **Sixth priority** must be given to all other applicants.


Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under [Schedule 20, Clause 3 \(1\)](#) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

Applicants may be required to give proof of address or sibling relationship.

The guidelines for development and operation of enrolment schemes are issued under Schedule 20, Clause 3 (3) of the Education and Training Act 2020 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.
